## **Terms & Conditions of Entry**

- 1. Information on how to enter and prize details form part of these terms & conditions (**Terms of Entry**). The Terms must be read in conjunction with the Schedule. The Schedule defines the terminology used in these Terms of entry. Where there is any inconsistency between these Terms and the Schedule, the Schedule prevails. - 3. - 23. Without limiting any of the foregoing, in no circumstances will a Registrant or the Promoter have any liability to the other for any loss or damage suffered which is indirect or consequential in nature, including without limitation any loss of profit, loss of reputation, loss of goodwill, or loss of business opportunity.
- 24. The Promoter and its associated agencies and companies will not be liable for any damage in transit to or delay in transit of gift.
- 25. The Promoter may in its absolute discretion not accept a particular entry, may disqualify an entry, or cancel the entire Promotion at any time without giving reasons and without liability to any Registrants, subject to any written directions from a regulatory authority.
